Mr. Buffett disclaims beneficial ownership of the reported securities except to the extent of his pecuniary interest therein.
- 3. 2,595,041 of the total reported securities are owned as of September 9, 2020 by Berkshire Hathaway Consolidated Pension Plan. Each of Berkshire, Mr. Buffett and this pension plan disclaim beneficial ownership in such shares.
