The number of common shares issuable under the award may range from zero to 200% of the target number of performance share units (1,734) based upon the Company's achievement of certain performance objectives during the relevant performance periods as described in more detail in the Company's proxy statement filed with the SEC on April 25, 2023. Based upon the Company's achievement of such objectives for such periods, the performance share unit award vested at 25.91% of target.
- Each restricted stock unit represents a contingent right to receive one common share of Axalta Coating Systems Ltd.
- This restricted stock unit grant vests in three equal annual installments beginning on the first anniversary of the grant date.
